Claims	Claim Field Report	A program that will allow users to custom build their own claim reports using all available claim data.
Contributions	Reciprocal Flag in Work History Display	This alert will identify any work history record that's already been reciprocated based on our reciprocal processing module.
General	Ability to Look Up All Checks Across Modules	This allows for a central place to view all checks issued across multiple modules.
General	Auto Wrapping Text in Comments	This allows the system to auto wrap words as typing in Participant and Dependent Comments.
Pension	Multiple States - State Withholding Calculation	The ability to withhold state taxes. Only available for certain known states and only one state withholding at a time.

General	SSN Masking in Ultra	Member SSNs can now be masked across all member maintenance screens displaying only the last four digits to enhance data privacy.

General	Look up Member by Dependent Date of Birth	This enhancement gives users the ability to search for members by Dependent Date of Birth, in addition to existing options like Dependent SSN and Name, using the F7 key.
General	Gender Identity Field in Participant Maintenance	This new standard field can be added to Participant Maintenance to track Gender Identity to support vendor requests for expanded demographic data

Accounting	Combined Cash Journal for Core/iRemit	This new program combines the Cash Receipts Journal and the Web Cash Receipts Journal to report on both core funds and web only funds.
Claims	BCBSI PDF Image	When Blue Cross provides Images associated with claims in a data file, tho images can be viewed up at a claim level through an application link.
Claims	Standard Claims Subrogation Maintenance Screen	A new subrogation screen has been added to track legal cases involving injuries caused by accidents (e.g., car accidents). When the Fund pays for medical expenses, this screen helps track potential liability from third-party insurers, ensuring the Fund can pursue reimbursement.
Claims	Claims Auto Adjudication Dashboard	This screen is used to track claim auto adjudication statistics.
General	Lookup Member by Beneficiary SSN and Phone Number	This enhancement gives users the ability to search for members by the Beneficiary SSN or Phone Number using the F7 key.
General	Enhanced COB Tracking for Medicare	This enhancement allows for tracking various components of Medicare Coverage.
General	Zip Code Address Validation	This enhancement allows for validation between the city and zip code for

Work History	Cash PMF Reconciliation Report	Compares PMF to Cash Receipt and has options to report on differences only
Work History	Contributions Inquiry	Allows inquiry on a single participant for work/contribution history for all or a single fund
Work History	Paystub Hours Report	Reports on any month a participant has paystub hours (Employer with class code PS) as well as reported hours under an existing employer. Used by Fund to identify and manually remove paystub hours
